But his letters also show strong ties to home and his need for those ties in order to maintain his own mental and emotional equilibrium in the face of the horrors of war. Elizabeth’s letters reflect an urban setting and the perspective of a young, recently married woman who spent much of her time parenting three young children from Frederic’s first marriage. In fact, children and parenting assume a theme in Fred and Lizzie’s correspondence almost as constant and consequential as the war itself. Providing background and framework for these exceptional letters, editor Charles E. Rankin’s introduction and contextualization create a continuous narrative that allows readers to follow these correspondents through a time critical to their marriage and to our nation’s history.
