He also charts the commercial, critical, and political response to these endeavors, including an historical footnote to the Red Scare unavailable in existing Cold War literature. A complete and detailed discography listing every YPR and CRG recording, including all known writers and performers, concludes this excellent reference for scholars, nostalgists, and phonographic fanatics.
