In LaCapra's view Zizek's provocative thought at times has uncanny echoes of earlier reflections on, or apologies for, political and seemingly regenerative, even sacralized violence.

This paper critiques the assumption that expanded enrollment since the early nineteenth century was a reflection of democratization and provides data from Germany, France, England, and Scotland to support a two-stage process of expanded schooling in which little increased access to the most favored occupations results. Also provided is a review essay by W. Bruce Leslie, The Academic Revolution Across Three Cultures,. An annotated list of recent dissertations in the field is included. Each of the four major papers contains extensive reference notes. (DB)
