A Class C commercial driver's license is required to operate a vehicle that is designed to seat more than 15 persons, including the driver, or transport hazardous materials (HazMat), that are classified as hazardous under Federal Law. With a Class C CDL and the proper endorsements, you may drive the following types of vehicles: -Small HazMat vehicles-Passenger vans-Combination vehicles not covered by Classes A or B-EXAMPLE: A small truck towing a trailer
