Valuation provides a consistent framework to understand human-nature interactions across a broad range of coastal and marine resources, and to evaluate the costs and benefits of these interactions. The focus on ecosystem services provides new research on this perspective of human-nature interactions that has profoundly changed the academic dialogue on natural systems, but has had limited impact on public dialogue and the policy process.

After five years of this joint undertaking we had concluded that it was in the interest of all concerned if the printing and distribution of the volume were handled by an international publishing house to assure improved service and broader dissemination.
