BALFOUR DECLARATION EXPRESSED BRITISH SUPPORT FOR A "NATIONAL HOME FOR THE JEWISH PEOPLE," INTENSIFYING JEWISH IMMIGRATION AND LAND PURCHASES. THIS LED TO INCREASED FRICTION WITH THE ARAB POPULATION, WHO OPPOSED THE LOSS OF LAND AND FEARED MARGINALIZATION.

FORMATION OF ISRAEL AND FIRST ARAB-ISRAELI WAR

IN 1947, THE UNITED NATIONS PROPOSED PARTITIONING PALESTINE INTO SEPARATE JEWISH AND ARAB STATES, WITH JERUSALEM UNDER INTERNATIONAL ADMINISTRATION. PALESTINIANS

PALESTINIANS ARE THE ARAB PEOPLE ORIGINATING FROM HISTORIC PALESTINE, NOW LIVING IN THE WEST BANK, GAZA STRIP, ISRAEL, AND THE DIASPORA. THEIR PRIMARY POLITICAL ORGANIZATIONS INCLUDE THE PALESTINE LIBERATION ORGANIZATION (PLO), ESTABLISHED IN 1964, AND HAMAS, WHICH GOVERNS THE GAZA STRIP SINCE 2007. ISRAELIS

KEY EVENTS AND TURNING POINTS

1948 ARAB-ISRAELI WAR AND PALESTINIAN EXODUS

ASSIGNED BY THE UN PARTITION, WHILE JORDAN OCCUPIED THE WEST BANK AND EGYPT CONTROLLED GAZA.

1967 SIX-DAY WAR AND OCCUPATION

IN 1967, ISRAEL FOUGHT NEIGHBORING ARAB STATES IN THE SIX-DAY WAR, CAPTURING THE WEST BANK, GAZA STRIP, EAST JERUSALEM, SINAI PENINSULA, AND GOLAN HEIGHTS. THE OCCUPATION OF THESE TERRITORIES BECAME CENTRAL TO THE CONFLICT, WITH PALESTINIANS DEMANDING AN END TO ISRAELI CONTROL AND THE ESTABLISHMENT OF AN INDEPENDENT STATE.

INTIFADAS (UPRISINGS)

Shaped by the pressures of American domestic politics and the special relationship with Israel, Washington's distinctive "blind spot" to Israeli power and Palestinian politics has deep historical roots, dating back to the 1917 Balfour Declaration and the British Mandate. The size of the blind spot has varied over the years and from one administration to another, but it is always present.
