The standards in this publication are based on language from ANA's Nursing: Scope and Standards of Practice, Second Edition, a helpful supplement to this specialty text, which in turn is of optimal use with two complementary ANA texts: Nursing's Social Policy Statement: The Essence of the Profession and Guide to the Code of Ethics for Nurses: Interpretation and Application. These three books are also available as a set, ANA's Foundation of Nursing 2010 Package, to guide nursing practice, thinking, and decision-making.
