In short, they ended up helping to dismantle powerful gendered stereotypes that had often reigned unquestioned in opera houses until then.

But when the response to Smith's offer fell radically short of his high hopes, Smith's zeal cooled. Timbuctoo, Freeman's Home, Blacksville and other settlements were forgotten. History would marginalize this Black community for 150 years. In *The Black Woods*, Amy Godine recovers a robust history of Black pioneers who carved from the wilderness a future for their families and their civic rights. Her immersive story returns the Black pioneers and their descendants to their rightful place at the center of this history. With stirring accounts of racial justice, and no shortage of heroes, *The Black Woods* amplifies the unique significance of the Adirondacks in the American imagination.
