4. We have disagreements about how to raise our children. How do we navigate this? Establish clear boundaries regarding parenting decisions. Agree on key principles and find ways to compromise on minor differences. Consider seeking professional guidance if disagreements become deeply entrenched.
5. How can I help my daughter navigate the tension between her father and her husband? Encourage open and honest communication between both parties. Offer support to both, but avoid taking sides. Remind them of their shared love for your daughter, and encourage them to find

common ground.
