THE SCRAMBLE FOR AFRICA

IN THE LATE NINETEENTH CENTURY, EUROPEAN POWERS RACED TO CLAIM TERRITORIES IN AFRICA, A PERIOD KNOWN AS THE SCRAMBLE FOR AFRICA. THE BERLIN CONFERENCE OF 1884-1885 FORMALIZED THE PARTITIONING OF THE CONTINENT, WITH BELGIUM, LED BY KING LEOPOLD II, ACQUIRING A VAST TERRITORY IN CENTRAL AFRICA UNDER THE GUISE OF HUMANITARIAN

REFORM AND ANTI-SLAVERY INITIATIVES.

CREATION OF THE CONGO FREE STATE

LEOPOLD MANAGED TO CONVINCE EUROPEAN LEADERS THAT HE WOULD BRING CIVILIZATION AND PROGRESS TO THE CONGO. IN REALITY, HE ESTABLISHED THE CONGO FREE STATE AS HIS PERSONAL DOMAIN, SEPARATE FROM THE BELGIAN GOVERNMENT. UNDER HIS CONTROL, THE REGION BECAME A LABORATORY FOR COLONIAL EXPLOITATION, CENTERED ON THE EXTRACTION OF RUBBER AND IVORY.

KING LEOPOLD II: AMBITIONS AND METHODS

LEOPOLD'S COLONIAL VISION

KING LEOPOLD II ASPIRED TO MAKE BELGIUM A COLONIAL POWER AND SOUGHT A TERRITORY THAT WOULD ELEVATE HIS INTERNATIONAL STATUS. HE USED ELABORATE PROPAGANDA AND PHILANTHROPIC RHETORIC TO MASK HIS TRUE INTENTIONS, PRESENTING HIMSELF AS A BENEFACTOR WHILE ORCHESTRATING A SYSTEM OF FORCED LABOR AND RESOURCE EXTRACTION.

MECHANISMS OF EXPLOITATION

- FORCE PUBLIQUE: A PARAMILITARY FORCE CREATED TO ENFORCE QUOTAS AND SUPPRESS RESISTANCE.
- HOSTAGE-TAKING: FAMILIES WERE HELD HOSTAGE TO ENSURE THE
