MEDIA OUTLETS SOMETIMES FOCUS ON THE SHOCK VALUE OF SUCH STORIES, OVERSHADOWING THE UNDERLYING ISSUES OF MENTAL HEALTH, FAMILY DYSFUNCTION, AND LEGAL RAMIFICATIONS. RESPONSIBLE REPORTING SHOULD PRIORITIZE FACTS, PROVIDE CONTEXT, AND AVOID EXPLOITING THE INDIVIDUALS INVOLVED FOR RATINGS OR CLICKS.

#### INFLUENCE ON PUBLIC OPINION

PUBLIC PERCEPTION IS SHAPED BY MEDIA NARRATIVES, WHICH CAN EITHER PERPETUATE STIGMA OR ENCOURAGE EMPATHY AND UNDERSTANDING. IT IS IMPORTANT FOR SOCIETY TO APPROACH THESE TOPICS THOUGHTFULLY, RECOGNIZING THE COMPLEXITY AND SENSITIVITY INVOLVED.

### ETHICAL ISSUES AND PROFESSIONAL SUPPORT
