However, Greenaway is an artist whose work also includes painting; collage; experimental TV; the novel/opera *Rosa*; and numerous exhibitions/installations, including *The Stairs*, a continuing series of ten projects in ten cities exploring the basic components of cinema. *Being Naked Playing Dead* explores the complete oeuvre, but centres firmly on Greenaway's insistence that his is 'a cinema of ideas not plots'. Each film is discussed within a thematic analysis of the full range of Greenaway's output and the wider contexts within which it is conceived. In conclusion there are two extended interviews, making this book essential reading for all Greenaway enthusiasts.

Including numerous visual examples, the book also argues that the relic represents the slippage between corpse and treasure, sentimentality and materialism, and corporeal fetish and aesthetic accessory. Zigarovich's analysis compels us to reassess the eighteenth-century response to and representation of the dead and dead-like body, and its material purpose and use in fiction. In a broader framework, *Death and the Body in the Eighteenth-Century Novel* also narrates a history of the novel that speaks to the cultural formation of modern individualism.
